

**NOTICE OF PARTIAL RELEASE OF
FIRST LIEN SECURITY INTEREST IN PATENTS AND TRADEMARKS**

THIS NOTICE OF PARTIAL RELEASE OF FIRST LIEN SECURITY INTEREST IN PATENTS AND TRADEMARKS ("Partial Release") is made as of January 12, 2024, by ALLY BANK, as collateral agent (together with its successors and assigns in such capacity, "Agent"), in favor of CURRENT LIGHTING SOLUTIONS, LLC (together with its successors and assigns, the "Grantor").

WHEREAS, pursuant to that certain First Lien Intellectual Property Security Agreement, dated as of February 1, 2022 (the "IP Security Agreement") between Grantor and Agent, and recorded in the United States Patent and Trademark Office on February 2, 2022 at Reel/Frame 058982/0844, the Grantor assigned to and granted to Agent, for the benefit of the Secured Parties (as defined in the IP Security Agreement), a lien on and security interest in all right, title and interest of the Grantor in, to and under the patents and patent applications listed on Schedule A hereto (the "Released Patents").

WHEREAS, pursuant to that certain IP Security Agreement recorded in the United States Patent and Trademark Office on February 2, 2022 at Reel/Frame 7607/0828, the Grantor assigned to and granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all right, title and interest of the Grantor in, to and under the trademarks and trademark applications listed on Schedule B hereto (the "Released Trademarks").

WHEREAS, the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release, relinquishment and discharge of its liens on and security interest in the Released Patents and the Released Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent, without any representation and warranty and without any recourse to Agent, hereby terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has in the Released Patents and the Released Trademarks. For the avoidance of doubt, Agent reserves to itself, as agent for itself and the Secured Parties, the security interest granted to Agent by Grantor in all other Patents listed on Schedule A to the IP Security Agreement and all other Trademarks listed on Schedule B to the IP Security Agreement.

Agent hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Partial Release.

THIS PARTIAL RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
