

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "<u>Termination</u>"), is dated as of December 30, 2014, and made by General Electric Capital Corporation, in its capacity as administrative agent for the Lenders (the "<u>Grantee</u>") to Excelligence Learning Corporation, a Delaware corporation (the "<u>Grantor</u>").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of January 28, 2013, made by the Grantors in favor of the Grantee ("Security Agreement 4"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of July 2, 2013, made by the Grantors in favor of the Grantee ("Security Agreement 5"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 4, 2013, made by the Grantors in favor of the Grantee ("Security Agreement 6" and, together with Security Agreement 1, Security Agreement 2, Security Agreement 3, Security Agreement 4 and Security Agreement 5, the "Security Agreements"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, Security Agreement 1 was recorded in the Trademark Division of the United States Patent and Trademark Office on September 6, 2011, at Reel 4617 and Frame 0572;

WHEREAS, Security Agreement 2 was recorded in the Trademark Division of the United States Patent and Trademark Office on December 5, 2011, at Reel 4671 and Frame 0985;

WHEREAS, Security Agreement 3 was recorded in the Trademark Division of the United States Patent and Trademark Office on March 22, 2012, at Reel 4741 and Frame 0739;

WHEREAS, Security Agreement 4 was recorded in the Trademark Division of the United States Patent and Trademark Office on January 30, 2013, at Reel 4952 and Frame 0647;

WHEREAS, Security Agreement 5 was recorded in the Trademark Division of the United States Patent and Trademark Office on July 8, 2013, at Reel 5065 and Frame 0034;

WHEREAS, Security Agreement 6 was recorded in the Trademark Division of the United States Patent and Trademark Office on September 12, 2013, at Reel 5111 and Frame 0133; and

WHEREAS, the Grantee now desires to terminate and release the Security Agreements;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

- 1. <u>Definitions</u>. The term "Trademark Collateral," as used herein, shall have the meaning set forth in each Security Agreement, as applicable, and shall include all of the applicable Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on <u>Schedule A</u> hereto, together with the goodwill of the business symbolized thereby.
- 2. <u>Release of Security Interest</u>. The Grantee hereby (i) terminates the Security Agreements and terminates, releases and discharges all liens and security interests in, and reassigns to Grantor, all right, title, and interest the Grantee may have in, to, or under, the Trademark Collateral; (ii) agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Grantee's rights under the Security Agreements with respect to the Trademark Collateral.
