PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Partial Release") dated as of January 17, 2024, made by JPMorgan Chase Bank, N.A., as administrative agent for the Lenders (together with any successors and permitted assigns thereto, in such capacity, the "Administrative Agent"), is in favor of FUNKO, LLC, a Washington limited liability company ("Funko") and FUNKO GAMES, LLC, a Washington limited liability company ("Funko Games", and together with Funko, each a "Grantor" and collectively, the "Grantors"). All capitalized terms used by not otherwise defined herein have the meanings given to them in the Trademark Agreement (as defined below).

WHEREAS, the Grantors and the Administrative Agent entered into that certain (i) Pledge and Security Agreement, dated as of September 17, 2021 (the "Security Agreement"), by and among, the Grantors, the other parties party thereto and the Administrative Agent and (ii) Confirmatory Grant of Security Interest in United States Trademarks, dated as of September 17, 2021 (as amended, modified or supplemented prior to the date hereof, the "Trademark Agreement" and together with the Security Agreement, the "Security Documents"), granting Administrative Agent security interests in and liens on certain trademarks described therein;

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on September 20, 2021, at Reel 007426, Frame 0450 with respect to the United States registered trademarks and trademark applications owned by Funko Games;

WHEREAS, the Trademark Agreement was recorded with the USPTO on September 20, 2021, at Reel 007426, Frame 0462 with respect to the United States registered trademarks and trademark applications owned by Funko;

WHEREAS, the Administrative Agent now desires to release and discharge its security interest in the United States registered trademarks and trademark applications set forth in Schedule A hereto (the "Released Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges all pledges, grants, liens and security interests in each Grantor's right, title and interest in, to the Released Trademark Collateral, which is identified in Schedule A hereto;
2. authorizes and requests that this Partial Release be recorded at the USPTO; and
3. understands and agrees that this Partial Release may be recorded by any Grantor, or their successors or assigns with the USPTO.


The Security Documents remain in full force and effect, as amended or modified by this Partial Release. Nothing herein shall be construed as (a) terminating the Security Documents or (b) terminating, releasing, canceling or discharging any pledge, grant, lien or security interest in favor of the Administrative Agent pursuant to the Security Documents, other than the Released Trademark Collateral set forth in Schedule A hereto.

THIS PARTIAL RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS PARTIAL RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
