**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of July 12, 2022, by CHINA CITIC BANK CORPORATION LIMITED, GUANGZHOU BRANCH, a China joint stock limited company (the “Collateral Agent”) in favor of LEXMARK INTERNATIONAL, INC., a Delaware corporation, located at 740 West New Circle Road, Lexington, Kentucky 40550 (the “Pledgor”).

W I T N E S S E T H:

WHEREAS, the Pledgor entered into a certain trademark security agreement dated April 2, 2018 (the “Trademark Security Agreement”) with Collateral Agent

WHEREAS, notice of the Trademark Security Agreement was recorded on August 30, 2018 at the United States Patent and Trademark Office (the “USPTO”) at Reel 6427, Frame 0214;

WHEREAS, the Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in all of such Pledgor’s right, title and interest in, to and under the Trademarks included in the Pledged Collateral, together with all associated Goodwill, wherever located, and whether now existing or hereafter arising or acquired from time to time, including those trademarks of Pledgor listed on Schedule I attached hereto, (collectively, the “Trademark Collateral”); and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all the Trademark Collateral as herein provided;

NOW, THEREFORE, in good and valuable consideration of the foregoing and intending to be legally bound, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby states as follows:

1. Definitions. Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Collateral Agent hereby terminates the Trademark Security Agreement and irrevocably terminates, cancels, releases and discharges the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, whether granted pursuant to the Trademark Security Agreement or otherwise, in the Trademark Collateral, including, but not limited to, the Trademarks listed on Schedule I hereto, and, all associated goodwill, and, without representation, recourse or warranty whatsoever, reassigns, transfers and conveys to Pledgor all right, title and interest of Collateral Agent in the Trademark Collateral, including all associated goodwill, and any right, title or interest of Collateral Agent shall hereby terminate, cease and become void.
3. Further Assurances. Collateral Agent authorizes Pledgor, and each of them, or an authorized representative of Pledgor, to record this Termination with the USPTO and/or otherwise record or file this Release in the applicable governmental office or agency. Collateral Agent further agrees to execute and deliver to Pledgor any and all further documents and instruments, and do any and all further acts which Pledgor (or its agents or designees) reasonably requests (at Pledgor’s sole cost and expense) in order to

confirm, effectuate or record this Release and Pledgor's rights, title and interest in, to and under the Trademark Collateral.

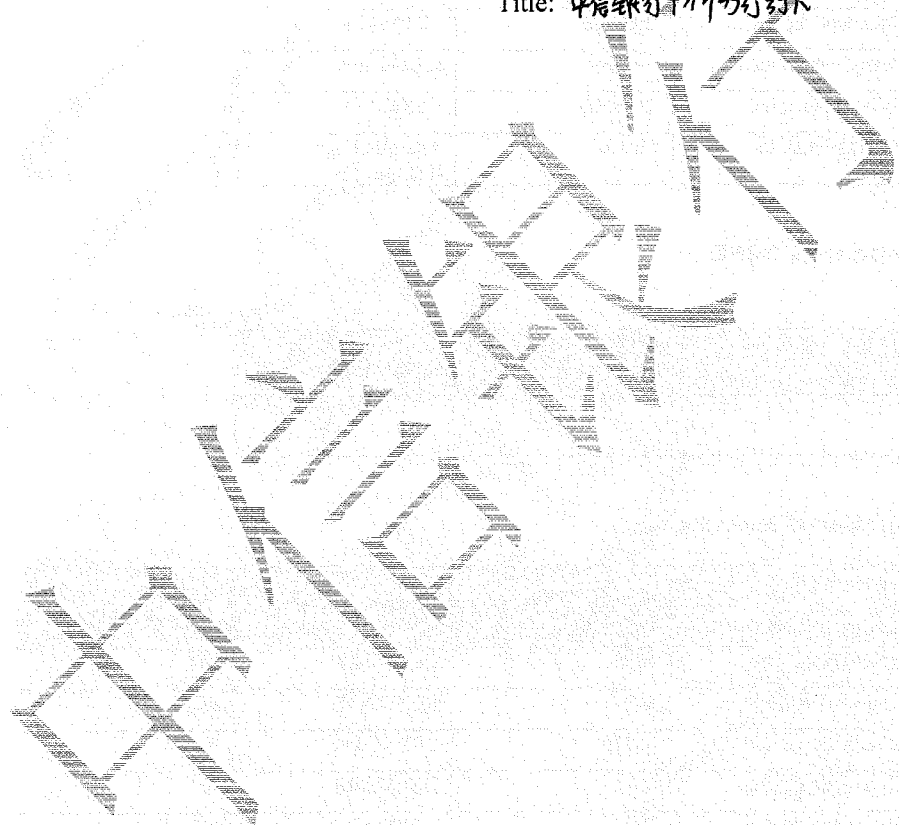
