Partial Release of Security Interest in Patents and Trademarks

This PARTIAL RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (the "Partial Release") is made effective as of January 16, 2024, by JPMorgan Chase Bank, N.A., in its capacity as administrative agent (the "Administrative Agent"), as described in the Patent and Trademark Security Agreement defined below (in such capacity, "Agent"), in favor of GRIMCO, INC., a Missouri corporation, GRIMCO MIDWEST, LLC a Nevada limited liability company, GRIMCO INTERNATIONAL, LLC, a Nevada limited liability company, Pioneer Trucking, LLC, a Nevada limited liability company, NHP TRUCKING, LLC, a New Hampshire limited liability company, (each a "Grantor", and collectively, the "Grantors")

WHEREAS, in connection with the Credit Agreement dated as of June 29, 2022 by and among Grantors, the other Loan Parties thereto, the Lenders party thereto, and Administrative Agent (the "Credit Agreement"), the Grantors executed that certain Patent and Trademark Security Agreement in favor of the Agent dated June 29, 2022 (as amended or modified from time to time, the "Security Agreement") pursuant to which Grantors pledged, assigned, and granted to Agent a security interest in, among other assets, all right, title and interest of Grantors in, to and under all then owned and thereafter acquired and under all now owned and hereafter acquired Patents, patent applications, patent licenses, Trademarks, trademark applications, and trademark licenses, and all products and proceeds thereof, (collectively, the "Patents and Trademarks"), including the Trademarks described on Schedule 1 annexed hereto and made a part hereof (Trademarks described on such Schedule 1, the "Released Trademarks"); and


WHEREAS Agent recorded its security interest in each item described on Schedule 1 of the Patent and Trademark Security Agreement in the United States Patent and Trademark Office on June 14, 2023, Reel 008099, Frame 0940.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined in this Partial Release shall have the respective meaning given to them in the Credit Agreement or Security Agreement, as the case may be.
2. Termination and Release of Security Interest. Agent does hereby terminate its security interest in the Released Trademarks. This Partial Release relates only to the Released Trademarks and except as to Released Trademarks, the Security Agreement remains full force and effect.
3. Further Assurances. Agent shall take all further actions and provide to Grantors such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments in form and substance acceptable to Grantors) reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Partial Release.
