INTELLECTUAL PROPERTY ASSIGNMENT
(Assets formerly of Hammerhead Navigation Inc.)

This Intellectual Property Assignment (“**Assignment**”) dated as of December 31, 2023 (the “**Effective Date**”) is entered into by and between SRAM-SP2, Inc., a Delaware corporation (“**Assignor**”) and SRAM, LLC, a Delaware limited liability company (“**Assignee**”).

- A. Hammerhead Navigation Inc., a Delaware corporation (“**HNI**”), recently merged with and into Assignor, with Assignor being the survivor of such merger (the “**SP2-HNI Merger**”).
- B. Assignor, upon the effectiveness of the SP2-HNI Merger, owns certain intellectual property assets that, immediately prior to the SP2-HNI Merger, were owned by HNI.
- C. Such intellectual property assets include, but are not limited to, Assignor’s right, title, and interest in and to the patents, patent applications, and trademarks described on Exhibit A to this Assignment (which exhibit is incorporated into this Assignment by reference), including, without limitation, all common law rights relating to the trademarks and all renewals and extensions that may be granted in connection with the registrations thereto, together with the goodwill of Assignor’s business associated with the trademarks and registrations, along with the inventions and all patent rights therefor, and the right to recover damages and profits for past, present, or future infringement thereof (such assets being the “**HNI IP Assets**”).
- D. After the SP2-HNI Merger, SRAM International Holdings, Inc., a Delaware corporation (“**SIH**”), contributed all of its ownership interests in SRAM Holdings, LLC, a Delaware limited liability company, to Assignor (the “**Contribution**”).
- E. Assignor desires to assign to Assignee, and Assignee desires to assume from Assignor, all of Assignor’s right, title, and interest in and to the HNI IP Assets as a successor-in-interest.

In consideration of the foregoing recitals, the mutual covenants herein contained, and other good and valuable consideration (the adequacy, sufficiency, and receipt of which hereby are acknowledged), the parties agree as follows:

1. **Assignment.** Assignor hereby, as of the Effective Date (but immediately after the Contribution) (such time after the Contribution being the “**Effective Time**”), irrevocably assigns, transfers, and conveys onto Assignee and its successors and assigns and legal representatives, for the territory of the United States of America and the entire world (i) the full and exclusive right, title and interest in and to all patents and patent applications included among the HNI IP Assets and all divisions, reissues, reexaminations, substitutions, continuations, continuations-in-part and extensions thereof, including any common law, statutory and other rights associated therewith, (ii) the right to recover damages and profits for past, present, or future infringement, misappropriation or other violation thereof, (iii) all rights under the International Convention for the Protection of Industrial Property, the same to be held and enjoyed by the said Assignee for its own use and profit and the use and profit of its successors, assigns and legal representatives, to the full end of the term or terms for which patents may be granted, (iv) the full and exclusive right, title and interest in and to the trademarks and registrations included among the HNI IP Assets,

together with the goodwill of Assignor's business symbolized by said trademarks and registrations, (v) all other rights that Assignor has enjoyed thereunder as trademarks, service marks, trade names, domain names and otherwise, including, without limitation, all rights and remedies based upon past infringement (including the right to sue and collect damages and profits for such infringement), and (vi) all other rights, title and interest in and to the HNI IP Assets, including, without limitation, trade secrets, know how, designs, inventions, and product specifications and including, without limitation, the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said inventions in appropriate registries.

2. **Authorization to Commissioner of Patents.** Assignor hereby authorizes and requests the Commissioner for Patents and Trademarks in the United States of America, and any comparable governmental authority or agency outside of the United States of America in which the HNI IP Assets are registered to transfer the HNI IP Assets to Assignee.

3. **Further Assurances.** From time to time after the Effective Date, and for no further consideration, Assignor will execute, acknowledge and deliver such assignments, transfers, consents, assumptions and other documents and instruments and take such other actions as may be requested by Assignee to effect the assignment of all rights, title and interest in and to the HNI IP Assets to Assignee, and to confirm and evidence such assignment and enable Assignee to secure, register, maintain, enforce and otherwise fully protect its rights, title and interest in and to the HNI IP Assets. Assignor, upon Assignee's request, will take all further actions, and provide Assignee and its successors, assigns and legal representatives all such cooperation and assistance (including, but not limited to, the execution and delivery of any and all affidavits, declarations, oaths, powers of attorney and other documentation), to more fully effectuate the purposes of this Assignment. If Assignee opts to take action against any actual or suspected infringers or other violators of any of the HNI IP Assets, upon Assignee's request, Assignor will provide Assignee all cooperation in connection therewith including, but not limited to, by offering testimony.




