The undersigned, being duly authorized to execute and file this Certificate of Formation, does hereby certify as follows:

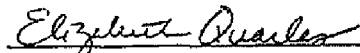
1. Name. The name of the limited liability company is Syngenta Crop Protection, LLC (the "Company").
