PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Partial Release"), dated as of January 18, 2024, is made by **BMO BANK N.A.** (f/k/a BMO Harris Bank N.A.), as collateral agent (the "Grantee"), in favor of **BEDDING ACQUISITION, LLC**, a Delaware limited liability company ("Bedding Acquisition"), **HOLLANDER CANADA BEDDING, INC.**, a British Columbia corporation ("Hollander Canada") and **SF HOME DÉCOR, LLC**, a Delaware limited liability company ("SF Home", together with Bedding Acquisition and Hollander Canada, collectively, the "Grantor");

WHEREAS, the Grantor, among others, has executed and delivered an Intellectual Property Security Agreement, dated as of September 19, 2022 (the "IP Agreement"), which was recorded with the United States Patent and Trademark Office (the "USPTO") on November 7, 2022, at Reel 7937 and Frame 0342;

WHEREAS, on or about the date hereof, certain trademarks owned by Bedding Acquisition, Hollander Canada and SF Home have been sold, transferred and assigned by the Grantor; and

WHEREAS, in connection with such sale, transfer and assignment, the Grantor has requested that the Grantee release and discharge fully its security interest in all of its right, title and interest in the trademarks set forth in Schedule A attached hereto (the "Specified Intellectual Property").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby release and discharge, without any representation or warranty, any and all liens and security interests it may have in and to the Specified Intellectual Property expressly identified in Schedule A (but not, for the avoidance of doubt, any proceeds received by the Grantor from the sale thereof).

The Grantee hereby authorizes and requests that the USPTO note and record this Partial Release.


Except for the release of Specified Intellectual Property identified on Schedule A attached hereto, all terms and provisions of the IP Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the IP Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any intellectual property pursuant to the IP Agreement or any other collateral document, other than the Specified Intellectual Property, shall remain unchanged and in full force and effect.**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
