PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK** (the “Partial Release”) is made as of January 18, 2024, by TCW ASSET MANAGEMENT COMPANY LLC, as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”), in favor of BEDDING ACQUISITION, LLC, a Delaware limited liability company (“Grantor”) with respect to the Released Trademarks (as defined below) as of the date hereof.

W I T N E S S E T H

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 19, 2022 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Trademark Security Agreement”) by Grantor in favor of Collateral Agent, Grantor granted to the Collateral Agent a security interest in and continuing lien on Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks identified on Schedule 1 attached hereto (the “Released Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office with respect to Trademarks on September 26, 2022 at Reel 7855, Frame 0535;

WHEREAS, Grantor requests a release of the Released Trademarks; and

WHEREAS, the Collateral Agent desires to terminate and grant a release of the Released Trademarks, as provided in this Partial Release.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby agree as follows:

1. The Collateral Agent hereby (a) releases, relinquishes, terminates and discharges the Released Trademarks in its entirety and (b) reassigns to Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Released Trademarks.
2. The Collateral Agent hereby (a) authorizes Grantor and its successors, assigns, designees or other legal representatives to file this Partial Release with the U.S. Patent and Trademark Office to evidence and effectuate the release and termination of the Collateral Agent’s security interest in the Released Trademarks and (b) authorizes the Commissioner for Trademarks to record and register this Partial Release.
3. All Trademarks covered by the Trademark Security Agreement, the Pledge and Security Agreement (as defined in the Trademark Security Agreement) and other documents pertaining to the obligations secured by the Pledge and Security Agreement, except for the Released Trademarks, shall remain subject to the liens and security interests of the Trademark Security Agreement, the Pledge and Security Agreement and all other documents pertaining to the obligations secured by the Pledge and Security Agreement shall not be affected hereby.
4. Delivery of an executed signature page of this Partial Release by facsimile or electronic transmission (e.g., email of a PDF file) shall be as effective as delivery of a manually executed counterpart hereof. The words “executed,” “signed,” “signature,” and words of like import in this Partial Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in


Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
