**TERMINATION OF SECURITY INTEREST IN
TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 18, 2024 (this "Termination and Release"), is made by ARES CAPITAL CORPORATION, a Maryland corporation, as Collateral agent (in such capacity, including any successor thereto, the "Collateral agent") for the Secured Parties under that certain Grant of Security Interest In Trademark Rights, dated as of April 11, 2018 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among CHILDREN'S FACTORY, LLC, a Delaware limited liability company, and EARLYCHILDHOOD LLC, a California limited liability company, (collectively, the "Grantors" and each a "Grantor") and the Collateral Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on May 7, 2018 in Reel 6382, Frame 0967, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of Grantors' right, title and interest in, to and under all of their Trademark Collateral, including, without limitation those set forth on the attached Schedule A;

WHEREAS, the Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and Lien on all Grantors' right, title and interest in, to and under the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Collateral Agent in the Released Collateral.
