CONFIRMATORY ASSIGNMENT AGREEMENT

This Confirmatory Assignment Agreement (this “**Confirmation**”), dated as of October 6, 2023 (the “**Execution Date**”) is executed by and between Aptiv Manufacturing Management Services S.à r.l. (“**AMMS**”), having an address of 12C, rue Guillaume J. Kroll, L-1882 Luxembourg, Grand Duchy of Luxembourg and Aptiv Technologies AG (“**ATAG**”), having an address of Pestalozzistrasse 2, 8200 Schaffhausen, Switzerland.

WHEREAS, prior to the Execution Date AMMS has been the sole owner of the Aptiv Intellectual Property (as defined below);

WHEREAS, on the Execution Date, AMMS is contributing the Aptiv Intellectual Property to ATAG pursuant to the Contribution Agreement, dated as of October 6, 2023, by and between AMMS and ATAG (the “**Contribution**”); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

I. DEFINITIONS

- a. “**Intellectual Property Rights**” means all registered and unregistered rights in concepts, discoveries, developments, designs, technologies, methods, products or inventions, databases and other data-based resources, works of authorship, symbols, names and images, including but not limited to: (i) all patents (including but not limited to utility models, industrial design registrations) and patent applications, together with all continuations, continuations-in-part, extensions, counterparts (whether foreign or domestic), divisions, revisions, reissues, and reexaminations thereof and all inventions and improvements claimed or described in any of the foregoing, including without limitation the right to file and claim priority from patent applications and be granted patents in respect of the same in any country or jurisdiction and all rights of priority under international conventions, treaties, or agreements; (ii) all copyrights (including but not limited to semiconductor chip mask work rights) and all applications, registrations and renewals therefor; (iii) all trade secrets and confidential business information (including but not limited to know-how, specifications, schematics, designs, drawings, flowcharts, block diagrams, technical data, and production processes and techniques); (iv) all computer software (including but not limited to related documentation); (v) trademarks (including but not limited to service marks, and other designations of source or origin) together with all goodwill associated therewith (“**Trademarks**”); (vi) internet domain names; (vii) all other proprietary rights, including but not limited to all rights of privacy and publicity; in each case to the extent that the existence of the foregoing is established by the applicable law and, where applicable, including but not limited to the right to claim priority under intellectual property conventions and laws; and (viii) all rights to exclude third

parties from practicing and using; to assert claims for past, present and future infringement, misappropriation or other violation; and to recover damages (including, without limitation, attorney's fees and expenses) and lost profits and to seek equitable relief.

- b. "**Aptiv Intellectual Property**" means all Intellectual Property Rights owned by or required to be assigned to AMMS as of the Execution Date, including but not limited to the Trademarks listed in **Exhibit A** hereto.

II. ASSIGNMENT

As of the Execution Date, the parties hereby agree that the Aptiv Intellectual Property has been and is hereby irrevocably assigned pursuant to the Contribution, from AMMS to ATAG and that ATAG is the sole owner of all right, title, and interest in and to the Aptiv Intellectual Property.

For the avoidance of doubt, as of the Execution Date, AMMS hereby confirms that ATAG owns (and is able to exercise without condition, limitation, or restriction) all worldwide rights of any kind in the Aptiv Intellectual Property held by AMMS prior to the Execution Date, including the right to use, sell, license, enforce, exclude, pledge, or otherwise convey or commit in whole or part any interest in the Aptiv Intellectual Property; the right to assert claims, recover damages and lost profits, and seek equitable relief for past, present and future infringement, misappropriation or other violation of the Aptiv Intellectual Property; and any and all other rights an owner of the Aptiv Intellectual Property would be able to exercise in any jurisdiction worldwide.

III. COUNTERPARTS


This Confirmation may be executed in any number of counterparts and thus have the same effect as if the signatures on the counterparts were on a single copy of this Confirmation.

The legal relationship created by and any dispute or claim arising out of or in connection with this Confirmation (including non-contractual disputes or claims) shall be subject to the nonexclusive jurisdiction of the courts of the State of Delaware, United States of America and the federal courts sitting within the State of Delaware, United States of America.


