


## CERTIFICATE OF NATIONAL BANK TITLE CHANGE

I, Michael J. Hsu, Acting Comptroller of the Currency, do hereby certify that:

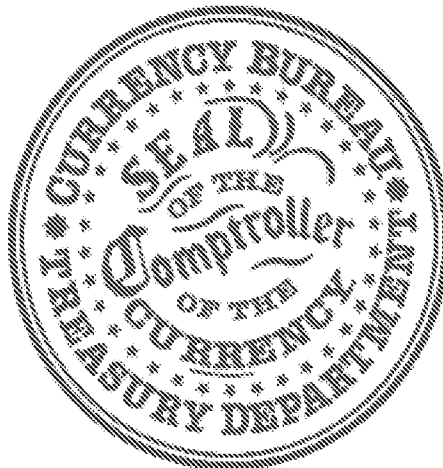
