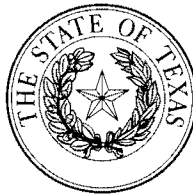

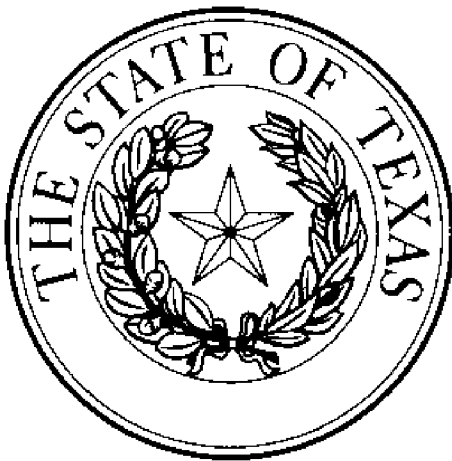

PURSUANT TO THE TEXAS BUSINESS ORGANIZATIONS CODE


