**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of December 19, 2023 by **SVB INNOVATION CREDIT FUND VIII, L.P. (F/K/A WESTRIVER INNOVATION LENDING FUND VIII, L.P.)**, as administrative agent and collateral agent for the certain lenders (the “*Assignee*”), in favor of **INTEGRICHAIN, INC.**, a Delaware corporation (“*IntegriChain*”), **PHARMAMETRICS, INC.**, a Pennsylvania corporation (“*PharmaMetrics*”), and **DAVIZTA INC.**, a Delaware corporation (“*DaVIZta*”, and together with IntegriChain and PharmaMetrics, each a “*Grantor*” and collectively, the “*Grantors*”).

**WHEREAS**, in connection with that certain Mezzanine Secured Credit Agreement, dated as of April 10, 2020, among, among others, the Grantors, the Assignee, and certain lenders party thereto (as amended by that certain Consent and First Amendment to Mezzanine Secured Credit Agreement, dated as of January 19, 2022, as further amended by that certain Second Amendment to Mezzanine Secured Credit Agreement dated as of August 2, 2023, as further amended by that certain Third Amendment to Mezzanine Secured Credit Agreement dated as of August 21, 2023, and as the same may be further amended, restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Credit Agreement*”), the Grantors and the Agent executed a Intellectual Property Security Agreement, dated as of April 10, 2020 (the “*Agreement*”), and granted to the Assignee a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on April 16, 2020, at Reel 6917, Frame 0624;

**WHEREAS**, each Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of each Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, each Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the certain Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in each Grantor’s right, title and interest in, to and under the Trademarks, (including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits) and all goodwill associated therewith, the right to sue for past, present, and future infringements, and all rights corresponding thereto throughout the world) including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

**THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED**

AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE UNITED STATES AND THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ANY CHOICE OR CONFLICT OF LAW PROVISION OR RULE (WHETHER OF THE STATE OF NEW YORK OR ANY OTHER JURISDICTION).
