RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "**Release**") is made by **SILICON VALLEY BANK**, a division of First-Citizens Bank & Trust Company ("**Bank**") in favor of **EX.CO TECHNOLOGIES LTD**, a limited company of Israel ("**Grantor**").

WHEREAS, Grantor has paid all of its outstanding indebtedness to Bank.

WHEREAS, the First Security Agreement was recorded with the United States Patent and Trademark Office on September 25, 2017 at Patent Reel/Frame: 043682/0213;

WHEREAS, the Second Security Agreement was recorded with the United States Patent and Trademark Office on February 12, 2020 at Trademark Reel/Frame: 6862/0678 and on February 12, 2020 at Patent Reel/Frame: 051912/0760;

WHEREAS, the Third Security Agreement was recorded with the United States Patent and Trademark Office on May 11, 2021 at Trademark Reel/Frame: 7288/0678 and on May 11, 2021 at Patent Reel/Frame: 056203/0673; and

WHEREAS, an amendment to the Third Security Agreement was recorded with the United States Patent and Trademark Office on April 04, 2022 at Trademark Reel/Frame: 7680/0232.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Bank hereby terminates the Security Agreements, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral and hereby assigns and transfers to Grantor any and all interest Bank may have in and to the Intellectual Property Collateral.

Bank represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral;

Bank shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

Bank hereby authorizes Grantor to record this Release with the United States Patent and Trademark Office and any other relevant agency throughout the world.
