RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of January 25, 2024 (this “Release”), is made by ANTARES CAPITAL LP, as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties (as defined in the Credit Agreement) in favor of OMNI LOGISTICS, LLC, a Delaware limited liability company and BIGGER, FARTHER, FASTER, LLC, a Delaware limited liability company (collectively, the “Grantors”).

WITNESSETH

WHEREAS, Omni Parent, LLC, a Delaware limited liability company, Omni Intermediate Holdings, LLC, a Delaware limited liability company, each lender from time to time party thereto (collectively, the “Lenders”), and Antares Capital LP, as administrative agent for the Lenders and as Collateral Agent, entered into that certain Senior Secured First Lien Credit Agreement, dated as of December 30, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, pursuant to the Credit Agreement, the Grantors and the Collateral Agent entered into that certain First Lien Security Agreement, dated as of December 30, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Intellectual Property Security Agreement, dated as of December 30, 2020 (the “IP Security Agreement”) and recorded with the U.S. Patent and Trademark Office on January 14, 2021 at Reel/Frame Nos. 7162/0708 and 7162/0717, pursuant to which the Grantors granted to the Collateral Agent for the benefit of the Secured Parties a security interest in all of their right, title and interest in and to the Collateral (as defined in the IP Security Agreement); and

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Collateral;

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Collateral under the Security Agreement and the IP Security Agreement.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.


