**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 25th day of January, 2024, by BAIN CAPITAL CREDIT, LP in its capacity as collateral agent (the “Collateral Agent”) for each of the Secured Parties (as defined in the Credit Agreement), in favor of OMNI LOGISTICS, LLC, a Delaware limited liability company, and BIGGER, FARTHER, FASTER, LLC, a Delaware limited liability company (collectively, the “Grantors”).

WHEREAS, Omni Parent, LLC, a Delaware limited liability company, Omni Intermediate Holdings, LLC, a Delaware limited liability company, each lender from time to time party thereto (collectively, the “Lenders”), and Bain Capital Credit, LP, as administrative agent for the Lenders and as Collateral Agent, entered into that certain Secured Second Lien Credit Agreement, dated as of December 30, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”).

WHEREAS, the Grantors entered into that certain Intellectual Property Security Agreement, dated as of December 30, 2020 with the Collateral Agent (the “IP Security Agreement”), notice of which was recorded with the United States Patent and Trademark Office on February 2, 2021 at reel/frame 7177/0412. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, each Grantor granted to the Collateral Agent, under the terms of the IP Security Agreement, a security interest in favor of the Collateral Agent for the benefit of the Secured Parties, in and to all of their right, title and interest in and to the Collateral, including without limitation the trademark registrations and applications listed in Schedule A hereto.

WHEREAS, Agent has agreed to terminate and release its security interest in all right, title and interest in and to the Collateral as herein provided.

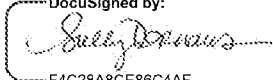
FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties (a) terminates the IP Security Agreement and hereby releases, terminates and discharges its security interest in the Collateral, including the trademark registrations and applications listed in Schedule A hereto and made a part hereof, and (b) if and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Collateral, the Collateral Agent hereby assigns, transfers and conveys to the applicable Grantor all of the Collateral Agent’s right, title and interest in such Collateral. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law or choice of law principles.


