THIRD: The name of the surviving corporation is L & W Supply Corporation.

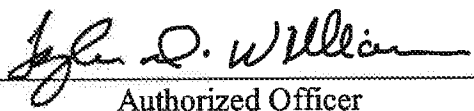
FOURTH: The merger is to become effective on filing.
