## DEED OF ASSIGNMENT OF REGISTERED TRADEMARKS

The marks and registrations are collectively referred to as the “Marks.” Assignor has adopted and has used the Marks.



NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer, sell, and convey to Assignee, all right, title, and interest in and to the Marks (including but not limited to Registration Nos. 3,664,939; 3,735,064; and 4,131,737), together with the goodwill of the business symbolized by such Marks and the registrations thereof, together with all rights of any kind whatsoever of Assignor accruing under the Marks provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; all such quality control standards, records, protocols, and information as are necessary to maintain the continuity of the quality of the goods and services represented by the Marks; and any and all claims and causes of action with respect to the Marks, whether accruing before, on, or after the date hereof, including all rights to and claims for royalties, license fees, damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, dilution, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages and other relief.
