Trademark Security Agreement

Trademark Security Agreement, dated as of January 25, 2024 (this “Trademark Security Agreement”), by A G WORLD TRANSPORT, INC., BIGGER, FARTHER, FASTER, LLC, EPIC FREIGHT SOLUTIONS LLC, FORWARD AIR ROYALTY, LLC, IVIA SERVICES, LLC, MACH 1 AIR SERVICES, LLC, MILLHOUSE LOGISTICS SERVICES, LLC, OMNI LOGISTICS, LLC, PACIFIC LOGISTICS, LLC, and TOWNE AIR FREIGHT, LLC (each individually, a “Pledgor,” and, collectively, the “Pledgors”), in favor of U.S. BANK TRUST COMPANY, NATIONAL ASSOCIATION, in its capacity as notes collateral agent pursuant to the Indenture (as defined below) (in such capacity, the “Notes Collateral Agent”).

W I T N E S S E T H:

WHEREAS, the Pledgors are party to a Security Agreement dated as of dated as of January 25, 2024 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Notes Collateral Agent pursuant to which the Pledgors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Notes Collateral Agent, for the benefit of the Secured Parties, to enter into the Indenture, dated as of October 2, 2023 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Indenture”), by and among Clue Opco LLC (as successor to GN Bondco, LLC), a Delaware limited liability company (the “Company”) and the guarantor parties thereto from time to time (the “Guarantors”) and U.S. Bank Trust Company, National Association, as trustee, the Pledgors hereby agree with the Notes Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. As collateral security for the payment and performance in full of all the Secured Obligations, each Pledgor hereby pledges and grants to the Notes Collateral Agent for the benefit of the Secured Parties, a Lien on all of the right, title and interest of such Pledgor in, to and under the following Collateral, wherever located, whether now existing or hereafter arising or acquired from time to time (collectively, and, in each case, excluding any Excluded Assets, the “Trademark Collateral”):

(a) (i) all trademarks, trade names, domain names, corporate names, business names, trade dress, service marks, logos, other source or business identifiers, all Registrations and recordings thereof; and all applications in connection therewith, including Registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof, including those set forth on Schedule I to this Trademark Security Agreement; (ii) all renewals thereof; and (iii) all goodwill associated with the foregoing, together with any and all (A) rights and privileges arising under applicable law with respect to such Pledgor’s ownership or use of any trademarks, (B) income, fees, royalties, damages and payments now or hereafter due and/or payable to Pledgor thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements thereof, (C) rights corresponding thereto throughout the world and (D) rights to sue for past, present and future infringement thereof; and

(b) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted concurrently and in conjunction with the security interest granted to the Notes Collateral Agent pursuant to the Security Agreement and Pledgors hereby acknowledge and affirm that the rights and remedies of the Notes Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to be inconsistent with or in conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Counterparts. This Trademark Security Agreement and any amendments, waivers, consents or supplements hereto may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original, but all such counterparts together shall constitute one and the same agreement. The words "execution," "signed," "signature," and words of like import in this Trademark Security Agreement shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.

SECTION 5. Governing Law. THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

SECTION 6. Intercreditor Agreements. Section 11.15 of the Security Agreement is incorporated by reference herein *mutatis mutandis*.





