TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (together with the schedule(s) attached hereto, this “Trademark Assignment”), dated and effective as of January 19, 2024 (the “Effective Date”), is entered into by and between NWN Parent Holdings LLC, a Delaware limited liability company with an address at 659 South County Trail Exeter, Rhode Island 02822 (“Assignor”), and NWN Corporation, a Delaware corporation with an address at 659 South County Trail Exeter, Rhode Island 02822 (“Assignee”).

2. Assignor authorizes and requests the Commissioner of Trademarks of the United States of America and the empowered officials of all other relevant governments to issue or transfer all Assigned Trademark to Assignee, as assignee of the entire right, title, and interest therein.


3. This Trademark Assignment may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Assignment by facsimile, email or other electronic transfer shall be effective as delivery of a manually executed counterpart to this Trademark Assignment.
