4. Accordingly, the FIRST Article of the Certificate of Incorporation shall, as amended, read as follows:

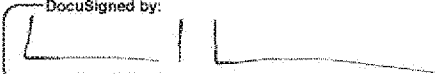
**"ARTICLE I**
