## Release of Intellectual Property Security Agreement

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of January 29, 2024 (this "**Release**"), by **GLOBAL LOAN AGENCY SERVICES AUSTRALIA NOMINEES PTY LIMITED**, as security trustee for the Secured Parties (the "**Security Trustee**"), for the benefit of INTEGRO INSURANCE BROKERAGE SERVICES, LLC (the "**Grantor**").

### WITNESSETH:

WHEREAS, pursuant to the Intellectual Property Security Agreement dated as of December 21, 2022 (the "**IP Security Agreement**"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the IP Security Agreement) between the Grantor and the Security Trustee, which IP Security Agreement was recorded in the United States Patent and Trademark Office (the "**Office**") on December 21, 2022, at Reel 7927, Frame 0059, the Grantor has granted a security interest in its right, title and interest in and to the intellectual property (the "**Intellectual Property**") to the Security Trustee, for the benefit of the Secured Parties.


WHEREAS, the Security Trustee (acting on behalf of the Secured Parties) has agreed to release the security interests created under the IP Security Agreement with respect to the Intellectual Property, which is listed in Schedule 1 (such items, collectively, the "**Released IP**"), on the terms and conditions set forth in that certain Deed of Release, dated January 18, 2024, by and among, among others, AUB Group Limited, as agent for the Grantor and certain other parties thereto, and the Security Trustee.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Trustee (acting on behalf of the Secured Parties) hereby releases the security interests over the Released IP created by the IP Security Agreement as of the date first written above.


