Assignor adopted and used, and was, up to February 1, 2013, the owner of the mark (“the **Mark**”) set forth in the attached Schedule A to this Trademark Nunc Pro Tunc Assignment (“**Assignment**”) and the United States registration for the Mark, as well as common law rights in the Mark and the associated good will.
