**Second Lien Release of Security Interest in Patents and Trademarks**

This Second Lien Release of Security Interest in Patents and Trademarks, dated as of **January 30, 2024** (the “Release”), is made by Golub Capital Markets LLC, as collateral agent (in such capacity, the “Collateral Agent”) in favor of Task Performance Group, Inc. listed as a grantor under the Second Lien Intellectual Property Security Agreement (as defined below) (a “Grantor”).

WHEREAS, by (i) that certain **Second Lien Security Agreement Supplement**, dated as of **July 29, 2021** in favor of Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related **Second Lien Intellectual Property Security Agreement**, dated as of **July 29, 2021** in favor of Agent (as amended, restated, or modified from time to time, the “Second Lien Intellectual Property Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Second Lien Intellectual Property Security Agreement, as applicable), which was recorded with the United States Patent and Trademark Office on **July 29, 2021** at Reel **057023** Frame **0504** for patents and Reel **7369** Frame **0696** for trademarks, Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of Grantor’s right, title and interest in, to and under the Collateral (as defined in the Second Lien Intellectual Property Security Agreement), including those Patents and Trademarks listed on Schedule I hereto;

WHEREAS, Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the Second Lien Intellectual Property Security Agreement), including, without limitation, the Patents and Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the Second Lien Intellectual Property Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.


The Agent authorizes and requests that the Commissioner for Patents and Trademarks, and any other applicable government officer record this Release.
