First Lien Release of Security Interest in Copyrights, Patents and Trademarks

This First Lien Release of Security Interest in Copyrights, Patents and Trademarks, dated as of **January 30, 2024** (the "Release"), is made by Golub Capital Markets LLC, as collateral agent (in such capacity, the "Collateral Agent") in favor of Exenta Inc., V-Technologies LLC, and Timesavers Inc. listed as a grantor under the First Lien Intellectual Property Security Agreement (as defined below) (a "Grantor").

WHEREAS, by (i) that certain **First Lien Security Agreement Supplement**, dated as of **December 10, 2021** in favor of Agent (as amended, restated, or modified from time to time, the "Security Agreement") and (ii) that certain related **First Lien Intellectual Property Security Agreement**, dated as of **December 10, 2021** in favor of Agent (as amended, restated, or modified from time to time, the "First Lien Intellectual Property Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or First Lien Intellectual Property Security Agreement, as applicable), which was recorded with the United States Copyright Office on **December 17, 2021** at Volume **15005 Digest 051**, and recorded with the United States Patent and Trademark Office on **December 14, 2021** at Reel **058389** Frame **0921 for patents** and Reel **7529** Frame **0573 for trademarks**, Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of Grantor's right, title and interest in, to and under the Collateral (as defined in the First Lien Intellectual Property Security Agreement), including those Copyrights, Patents and Trademarks listed on Schedule I hereto;

WHEREAS, Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the First Lien Intellectual Property Security Agreement), including, without limitation, the Copyrights, Patents and Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the First Lien Intellectual Property Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.


The Agent authorizes and requests that the Register of Copyrights and the Commissioner for Patents and Trademarks, and any other applicable government officer record this Release.
