## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “*Release*”) is made as of January 29, 2024 (the “*Effective Date*”) by VENTURE LENDING & LEASING VII, INC., a Maryland corporation, and VENTURE LENDING & LEASING VIII, INC., a Maryland corporation, both with an office at 104 La Mesa Dr., Suite 102, Portola Valley, California 94028 (together, the “*Grantors*”) in favor of DOLLY, INC., a Delaware corporation, with an address for notices as 9450 SW Gemini Dr., PMB 43895, Beaverton, OR 97008-7105 (the “*Grantee*”).

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of June 10, 2016 (the “*Security Agreement*”), the Grantee granted the Grantors a security interest in and to certain intellectual property owned by the Grantee, including, without limitation the intellectual property listed on Annex I attached to this Release (collectively, the “*Intellectual Property Collateral*”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 13, 2016 at Reel 5813, Frame 0809; and

WHEREAS, Grantee has fulfilled its obligations under the Security Agreement and the Loan and Security Agreement referenced therein (the “*Obligations*”), and Grantors now desire to terminate the Security Agreement and release its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Grantors hereby covenant and agree as follows:

1. Grantors hereby terminate, release, and discharge their security interests in the Intellectual Property Collateral, and reassign to Grantee any and all right, title, and interest, without recourse, representation or warranty, Grantors may have in or to the Intellectual Property Collateral pursuant to the Security Agreement.

2. Grantors hereby acknowledge and agree that Grantee has completely and timely satisfied its Obligations in full (other than any such Obligations that are contingent and/or not yet due or owing), and hereby terminate the Security Agreement. Grantors hereby confirm Grantee shall have no further obligations of any kind under the Security Agreement.
