**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 31, 2024 (the “Effective Date”), is made by GOLUB CAPITAL MARKETS LLC, as agent for the Secured Parties (in such capacity, the “Administrative Agent”) in favor of ROUGH COUNTRY, LLC, a Delaware limited liability company ( “Grantor”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Second Lien Security Agreement among the Grantor, the Administrative Agent, and certain other parties, dated as of July 28, 2021 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Security Agreement”), the Grantor executed and delivered that certain Trademark Security Agreement, dated as of July 28, 2021 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on July 28, 2021 at Reel/Frame 7367/0168;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor unconditionally granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, lien and mortgage in and to, right of setoff against and collateral assignment of (the “Security Interest”) all of the Grantor’s right, title and interest in and to the following Collateral, whether then owned or thereafter acquired or arising, but in any event excluding any Excluded Property: (a) all of its Trademarks and Trademark Licenses, including those referred to on Schedule I; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; (c) all rights, priorities and privileges related thereto and all rights to sue or otherwise recover for any past, present and future infringements, dilutions or other violations thereof; (d) all Proceeds of the foregoing; and (e) all other rights corresponding thereto (collectively, the “Trademark Collateral”); and

WHEREAS, the Administrative Agent and the Grantor acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, hereby absolutely, unconditionally, irrevocably and forever (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest and any other right, title or interest it may have in the Trademark Collateral, and (c) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to the Administrative Agent and without representation or warranty of any kind.

The Grantor, or any successor to the Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral), is hereby authorized to request that the Commissioner for Trademarks of the United States of America and any other applicable government officer to record this Release against the Trademark Collateral.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be executed and delivered by its duly authorized representative as of the Effective Date.


