## SALE, ASSIGNMENT AND TRANSFER AGREEMENT

NOW, THEREFORE, the parties agree as follows:

1. In consideration for the payment of One Dollar (US\$1.00), due and payable by Assignee to Assignor upon execution hereof, Assignor does hereby irrevocably sell, assign, transfer and set over to Assignee all of Assignor's right, title and interest in and to the Mark anywhere in the world, and all registrations therefore, including (without limitation) the United States Trademark Registration Numbers listed in Schedule A, for the Assignee's own use and enjoyment, and representatives, together with, without limitation, all claims for damages by reason of unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment or for the use and enjoyment of its successors or other legal representatives.

In connection herewith, Assignor hereby covenants and agrees immediately to take all action necessary on the part of Assignor to vest in Assignee all right, title and interest in and to the Marks, including (without limitation) the recordation of this Assignment with the United States Patent and Trademark Office. In the event that Assignee is unable, after reasonable effort, to secure Assignor's signature on any instruments necessary to vest in Assignee all right, title and interest in and to the Mark, as provided hereunder, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as Assignee's agent and attorney-in-fact, to act for and on Assignor's behalf and stead to execute and file any such instruments and to do all other lawfully permitted acts to further vest such right, title and interest in and to the Mark in Assignee with the same legal force and effect as if executed by Assignor.
3. Assignor warrants and represents that it has not previously assigned the Mark or licensed any interest thereon.
4. This Assignment shall be governed by and construed in accordance with the laws of the State of California without regard to principles of conflicts of laws.
