PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of this 26th day of January, 2024, by JPMORGAN CHASE BANK, N.A., as administrative agent ("Administrative Agent"), in favor of COLLINS BUS CORPORATION, a Kansas corporation ("Company").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby releases all liens and security interests granted by Company in favor of Administrative Agent in, to and under the Trademark Collateral (as defined in the Security Agreement, as defined below) of the Company, including the trademarks listed on Schedule A attached hereto and any other rights associated with such Trademark Collateral of the Company in which Administrative Agent was granted a security interest pursuant to that certain Trademark Security Agreement, dated as of April 13, 2021, executed by Company and certain other Debtors (as defined therein) in favor of Administrative Agent (the "Security Agreement") and recorded with the United States Patent and Trademark Office (the "USPTO") on April 13, 2021 at Reel 7254, Frame 0082. Any right, title or interest of Administrative Agent in such security interest in the Trademark Collateral of the Company, including the trademark listed on Schedule A, are terminated and void, and Administrative Agent hereby reassigns, grants and conveys to Company, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in and to and under the Trademark Collateral of the Company, including the trademarks listed on Schedule A. This Release does not affect Trademark Collateral of any other Debtor.

Administrative Agent hereby consents to the recording of this Release with the USPTO to note and record the existence of the releases hereby given.
