**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of January 31, 2024 by **AUDAX PRIVATE DEBT LLC**, as Administrative Agent and Collateral Agent for the Secured Parties (in such capacities and together with its successors and permitted assigns, the “Administrative Agent”) in favor of **ACCOLITE DIGITAL LLC**, a Delaware limited liability company with an address at 16479 Dallas Parkway, Suite 350, Addison, Texas 75001, and **COPPEREGG CORPORATION**, a Texas corporation with an address at 16479 Dallas Parkway, Suite 350, Addison, Texas 75001 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement April 10, 2023 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded by the United States Patent and Trademark Office on April 10, 2023 at Reel 8037, Frame 0902.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of each such Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of each Grantor (including the Security Interest), and assigns, transfers and conveys to each Grantor any right, title and interest in such intellectual property, including the Security Interest.

Each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral and Security Interest) is hereby authorized to record this Release with the United States Patent and Trademark Office, at the Grantors’ sole cost and expense.
