**ASSIGNMENT OF FIRST LIEN SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This ASSIGNMENT OF FIRST LIEN SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Assignment"), dated as of February 2, 2024, is entered into by and between CREDIT SUISSE AG, NEW YORK BRANCH ("Assignor") and JPMORGAN CHASE BANK, N.A. ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below), whether directly therein, or by reference to another agreement.

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of February 5, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Rhino Software, Inc., Librato, Inc., SolarWinds Worldwide, LLC, Galaxy Technologies, LLC and Confio Corporation (each a "Pledgor," and collectively, the "Pledgors"), Credit Suisse AG, Cayman Islands Branch (the "Original Agent") and certain other parties, Pledgors executed and delivered that certain First Lien Trademark Security Agreement, dated as of February 5, 2016 (the "Trademark Security Agreement"), pursuant to which each Pledgor pledged and granted to the Original Agent, for the ratable benefit of the Secured Parties, a Lien on and security interest in and to (the "Security Interest") all of such Pledgor's right, title and interest in, to and under the Trademark Collateral of such Pledgor, including the registered trademarks and trademark applications of such Pledgor listed on Schedule I hereto;

WHEREAS, the Original Agent recorded the Trademark Security Agreement with the United States Patent and Trademark Office ("USPTO") on February 5, 2016 at Reel/Frame 5724/0798 (with respect to Rhino Software), at Reel/Frame 5724/0819 (with respect to Librato), at Reel/Frame 5725/0001 and 5725/0110 (with respect to SolarWinds Worldwide), at Reel/Frame 5725/0065 (with respect to Confio), and at Reel/Frame 5725/0036 (with respect to Galaxy Technologies);

WHEREAS, Assignor succeeded the Original Agent as Collateral Agent, and in accordance therewith, the Original Agent assigned the Trademark Security Agreement, together with its Security Interest in the Trademark Collateral of each Pledgor, to Assignor pursuant to an Assignment of First Lien Security Interest in Trademark Collateral, dated December 27, 2022, which was recorded in the USPTO on December 27, 2022 at Reel/Frame 7930/0910;

WHEREAS, pursuant to that certain Resignation and Appointment Agreement, by and among Assignor, as Existing Agent (as defined therein), and Assignee, as Successor Agent (as defined therein), Assignor has resigned as collateral agent, and Assignee has been appointed as the Successor Agent, and accordingly Assignor has assigned to Assignee, and Assignee has assumed, all of Assignor's rights and obligations under the Security Agreement and the Trademark Security Agreement and the security interests granted thereunder; and

WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the USPTO.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under, the Trademark Collateral and the Trademark Security Agreement, including, without limitation, its Security Interest in the Trademark Collateral. The foregoing Assignment is made without recourse, representations or warranties of any kind.
