TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT

WHEREAS, Assignor is owner of the trademark registrations set forth in Schedule A attached hereto incorporated herein by reference, and any and all applied for and unregistered marks, trade dress, logos, slogans, get-ups and taglines (the "Trademarks");

WHEREAS, Assignor previously acquired certain Trademarks through the purchase of the following entities: DBT Deutsche Bergbau-Technik GmbH, Bucyrus Europe GmbH, and DBT GmbH. Such Trademarks shall be included in this Assignment Agreement as they are currently owned by Assignor.

WHEREAS, Assignor is owner of the domain names set forth in Schedule B, attached hereto and incorporated herein by reference (the "Domain Names");

WHEREAS, in connection with the Intellectual Property Transfer Agreement effective December 31, 2020, whereby Assignor transferred to Assignee all of Assignor's right, title, and interest in and to the Trademarks and Domain Names, together with all goodwill associated therewith; and

WHEREAS, the Parties desire to assign all right, title, and interest in and to the Trademarks and the Domain Names from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


Assignor does hereby assign and transfer to Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to the Trademarks and Domain Names, together with all goodwill associated therewith, and the right to sue and recover for, and the right to profits or damages due or accrued, arising out of or in connection with any and all past, present, or future infringements or dilution of the Trademarks.

Assignor agrees, at Assignee's request, that it shall promptly take such actions as may be reasonably necessary in order to render this Assignment fully effective, including unlocking the Domain Names so as to permit their transfer, providing any authorization or other codes required for the transfer, and answering in the affirmative any request from the registrar of the Domain Names for authorization to complete the transfer. Assignor specifically agrees to execute and deliver as "administrative contact" on behalf of the "registrant" any and all documents or forms, delivered electronically or in any other medium, required to transfer the Domain Names to the registrar of Assignee's choice.


This Assignment is binding on the parties hereto and their respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
