1. The names of the parties to the merger are Hooker & Holcombe, Inc., a corporation organized and existing under the laws of the State of Connecticut, and USI Consulting Group, Inc., a corporation organized and existing under the laws of the State of Connecticut.

2. USI Consulting Group, Inc. will continue its existence as the surviving corporation under its present name pursuant to sections 33-600 to 33-998, inclusive, of the Act.

3. The effective date of the merger herein provided for shall be May 2, 2023.

4. The Certificate of Incorporation of the surviving corporation at the effective time and date of the merger shall be the Certificate of Incorporation of said surviving corporation and said Certificate of Incorporation shall continue in full force and effect until amended and changed in the manner prescribed by the provisions of the Act.

5. Approval of the shareholders of Hooker & Holcombe, Inc. was not required for the merger, pursuant to sections 33-600 to 33-998, inclusive, of the Act, and the certificate of incorporation of Hooker & Holcombe, Inc.

6. Approval of the shareholders of USI Consulting Group, Inc. was not required for the merger, pursuant to sections 33-600 to 33-998, inclusive, of the Act, and the certificate of incorporation of USI Consulting Group, Inc.
