**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 6, 2024, is made by PNC BANK, NATIONAL ASSOCIATION, as successor to BBVA USA (the “*Collateral Agent*”) in favor of AKUMIN INC., AKUMIN IMAGING TEXAS, LLC, AKUMIN FLORIDA HOLDINGS, LLC, ALLIANCE ONCOLOGY, LLC, ALLIANCE HEALTHCARE SERVICES, INC., THREE RIVERS HOLDINGS, LLC, AND USR HOLDINGS, LLC (each, a “*Grantor*” and, collectively, the “*Grantors*”).

**WHEREAS**, pursuant to the U.S. Pledge and Security Agreement, dated as of November 2, 2020 (the “*Pledge and Security Agreement*”), by and among the Grantors (as defined therein) party thereto and the Collateral Agent, the Grantors pledged, collaterally assigned and granted to the Collateral Agent a security interest in all of the Grantors’ right, title and interest in the “*Collateral*” (as defined therein), including the trademarks set forth on Schedules 1 and 2 attached hereto (the “*Trademarks*”);

**WHEREAS**, pursuant to that certain (x) Notice of Grant of Security Interest in Trademarks, dated as of November 2, 2020, by certain of the Grantors in favor of the Collateral Agent, which was duly recorded on November 2, 2020 at Reel 7123, Frame 0346 in the United States Patent and Trademark Office and which was placed on file in the Canadian Intellectual Property Office (the “*2020 Trademark Security Agreement*”) and (y) Notice of Grant of Security Interest in Trademarks, dated as of September 1, 2021, by certain of the Grantors in favor of the Collateral Agent, which was duly recorded on September 2, 2021 at Reel 7411, Frame 0818 in the United States Patent and Trademark Office (the “*2021 Trademark Security Agreement*”, and collectively with the 2020 Trademark Security Agreement, the “*Trademark Security Agreements*”), the Grantors granted to the Collateral Agent, to secure its obligations under the Pledge and Security Agreement, a security interest in all right, title and interest of the Grantors in and to certain intellectual property, including the Trademarks set forth on Schedules 1 and 2 attached hereto.

**WHEREAS**, the Collateral Agent wishes to release and restore all right, title and interest in the Trademarks to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreements.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under each Trademark Security Agreement in the Applicable Collateral (as defined in the applicable Trademark Security Agreement), including the Trademarks, (b) release its security interest in the Applicable Collateral, including the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Collateral Agent in the Applicable Collateral and all goodwill associated therewith, including the Trademarks.

Collateral Agent shall take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantors, and at the Grantors’ cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby. Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office and the Canadian Intellectual Property Office note and record the present Release of Security Interest in Trademarks.
