INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (“*IP Assignment Agreement*”), dated as of December 29, 2023, is made by and among MGG SPV 30 LLC, a Delaware limited liability company (“MGG SPV”), Pele IP Ownership LLC, a Delaware limited liability company (“Pele IP”, and, together with MGG SPV, each an “*Assignor*” and, together, the “*Assignors*”) and Pele Brand LLC, a Florida limited liability company (“*Assignee*”). Assignors and Assignee are referred to herein individually as a “Party” and collectively as the “Parties.”

WHEREAS, Assignors own certain intellectual property rights as listed in Schedule 1 to this Assignment (the “*IP*”).

WHEREAS, simultaneously herewith, the Parties are entering into an Asset Purchase Agreement contemplating, *inter alia*, that the IP owned by Assignors will be assigned to Assignee.

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, do hereby agree as follows:

1. **Assignment.** Assignors hereby assign to Assignee, as of the Effective Date, all of its right, title and interest in and to the IP, together with any goodwill of the business connected with and symbolized by the IP. Without limiting the foregoing, Assignors acknowledge and agree that the foregoing assignment to Assignee of the IP includes all rights appurtenant to the IP, including (i) the right throughout the world to apply for and prosecute, in its own name, applications for the registration of IP, including applications pending before the United States Patent & Trademark Office, United States Copyright Office or any other governmental authority and any foreign counterparts of the foregoing made under any existing or future international, bi-lateral or multi-lateral conventions, agreements or treaties, (ii) the right to maintain registrations issuing from such applications, and (iii) the right to enforce and defend the IP, including the right to sue third parties for past and present infringement of, and the right to sue third parties for future infringement of, the IP.

2. **Perfection of Assignments; Continuing Assistance.** To the extent that, notwithstanding the Parties’ intention, Assignors have retained or acquired any right, title or interest in or to any IP, Assignors hereby assign such right, title and interest to Assignee, as applicable, together with any goodwill of the business connected with and symbolized by the IP. Assignors will, at the request of Assignee and without further consideration, execute and deliver such additional documents and perform such additional acts as may reasonably be necessary or desirable to effectuate the purposes of this IP Assignment Agreement following receipt of a request from Assignee.

3. **Authority.** Each Party represents and warrants that it has full authority to enter into this Agreement. Each Party knowingly enters into this IP Assignment Agreement, has the legal capacity to enter into this IP Assignment Agreement and to carry out all obligations and requirements herein, and consulted or had the opportunity to consult with counsel to approve the form and content of this IP Assignment Agreement.

4. **Entire Agreement.** This IP Assignment Agreement constitutes the entire understanding between the Parties with respect to the subject matter hereof and supersedes all other understandings and agreements between them, whether written or oral.

5. **No Oral or Implied Modification or Waiver.** This IP Assignment Agreement may not be changed, modified, extended, terminated or discharged except in a writing signed by both Parties. No Party shall be deemed to have waived any of its rights hereunder except in a writing signed by both Parties and specifically referring to this IP Assignment Agreement and the right that is being waived.

6. **Governing Law.** This IP Assignment Agreement will be governed by and construed in accordance with the internal Laws of the State of Delaware applicable to agreements executed and performed entirely within such State without regards to conflicts of law principles of the State of Delaware or any other jurisdiction that would cause the Laws of any jurisdiction other than the State of Delaware to apply.



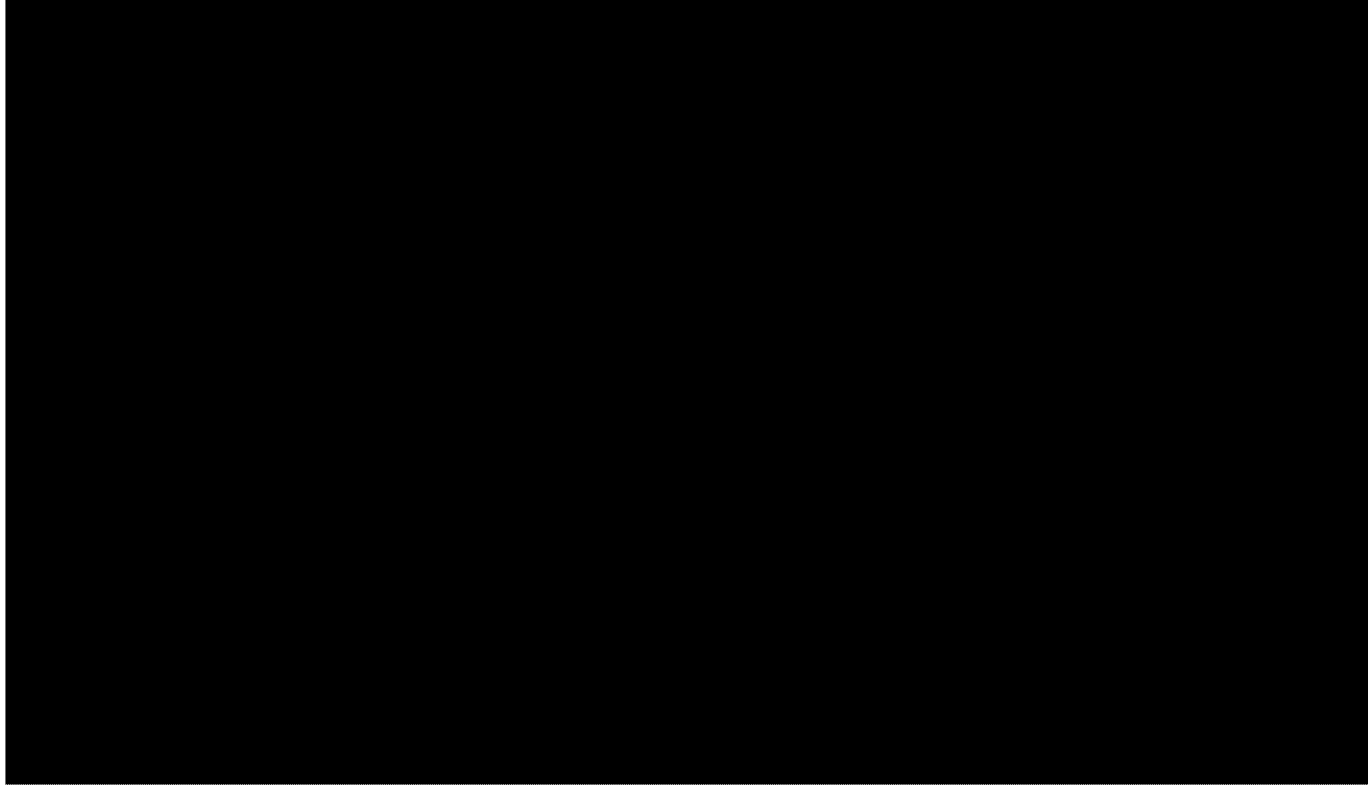
