TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is by and between G.O. Corporation I, a Minnesota corporation ("Assignor") and Wholesale Produce Supply, LLC, a Delaware limited liability company ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, all of Assignor's right, title and interest in and to the Trademarks, together with all goodwill associated with said Trademarks, and the right to sue and recover for, and the right to profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements or dilution of or damage to the Trademarks or the associated goodwill.

Assignor further agrees that, without further consideration, they will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignee may, from time to time, reasonably request to effect fully this Agreement and to permit Assignee to be duly recorded as the registered owners of the Trademarks in the United States. Assignor agrees to cooperate fully with Assignee to accomplish such recordation.

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute a single instrument.

This Agreement shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns.
