RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of June 30, 2016 (as the same may have been amended, modified, restated, replaced or supplemented from time to time, the “IP Security Agreement”; capitalized terms used herein have the definition provided for in the IP Security Agreement), recorded with the United States Patent and Trademark Office on August 5, 2016 at Reel/Frame No. 005848/0757; the Grantor granted to Agent, on behalf of the Lenders, a security interest in and to all of its right, title and interest in each Grantor’s Intellectual Property Collateral, including the Collateral listed in Exhibits A through C thereto;

WHEREAS, the Grantor has requested that Agent release its security interest in and to the Trademarks as more particularly described on Schedule A attached hereto (the “Released Trademarks”);

WHEREAS, the Grantor has requested that Agent release its security interest in and to the various intellectual property assets set forth in Sections (a) through (d) of the IP Security Agreement (together with the Released Trademarks, the “Released IP Collateral”).
