WHEREAS the Sellers operate a personal care company, including a diversified portfolio of four personal care brands;

AND WHEREAS on or about the date hereof, the Sellers will file an initial application for protection from their creditors and certain relief under the *Companies' Creditors Arrangement Act* (Canada) ("**CCAA**"), including seeking court approval of Alvarez & Marsal Canada Inc. as the court-appointed monitor of the Sellers (the "**Monitor**") (the date of such filing, the "**Filing Date**");




Section 1.1 Definitions

In this Agreement,





"Intellectual Property" means any and all right, title and interest in, to, arising out of, or associated with any of the following in any jurisdiction throughout the world: (a) issued patents and patent applications (whether provisional or non provisional), including divisionals, continuations, continuations in part, substitutions, reissues, foreign equivalents, international applications, reexaminations, extensions, or restorations of any of the foregoing, and other Governmental Authority issued indicia of invention ownership (including certificates of invention, design patents, industrial designs, petty patents, and patent utility models); (b) registered or unregistered trademarks, service marks, pending trademark and service mark registrations, brands, certification marks, logos, trade dress, trade names, and other similar indicia of source or origin, together with the goodwill connected with the use of and symbolized by, and all registrations, applications for registration, and renewals of, any of the foregoing; (c) registered and unregistered copyrights and works of authorship, whether or not copyrightable, and all registrations, applications for registration, and renewals of any of the foregoing; (d) internet domain names and social media account or user names (including "handles"), whether or not they include trademarks, all associated web addresses, URLs, websites and web pages, social media sites and pages, and all content and data thereon or relating thereto, whether or not copyrights; (e) trade secrets, know how, inventions (whether or not patentable), discoveries, improvements, technology, business and technical information, databases, data compilations and collections, tools, methods, processes, techniques, and other confidential and proprietary information and all rights therein; (f) computer programs, operating systems, applications, Software, firmware and other code, including all source code, object code, application programming interfaces, data files, databases, protocols, specifications, and other documentation thereof; and (q) all other intellectual or industrial property and proprietary rights;

This Intellectual Property Assignment and Assumption Agreement (this "Agreement") is made as of December 8, 2023 between RENPURE, LLC, a limited liability company formed under the laws of Delaware, having its head office located at 100 New Park Place, Suite 810, Vaughan, Ontario, L4K 0H9, THE MANE CHOICE HAIR SOLUTION LLC, a limited liability company formed under the laws of Delaware, having its head office located at 100 New Park Place, Suite 810, Vaughan, Ontario, L4K 0H9 (collectively the "Assignors") and MAV USA, LLC, a limited liability company organized under the laws of Delaware, having its head office located at 11150 Santa Monica Boulevard, Suite 400, Los Angeles, California 90025 (the "Assignee" and, together with the Assignors, the "Parties").

RECITALS:

- a) The Assignors, MAV Beauty Brands Inc., Marc Anthony Cosmetics Ltd., Marc Anthony Cosmetics USA, Inc. and MAV Midco Holdings, LLC (collectively, the "Sellers") and the Assignee (as Buyer) are parties to an asset purchase agreement dated November 13, 2023 (the "APA"), pursuant to which, among other things, the Assignors have agreed to sell, assign, transfer and convey to the Assignee or one or more of its designees, and the Assignee has agreed to purchase, acquire and accept from the Assignors directly or through one or more of its designees, all of the Assignors' right, title and interest as of the date of the APA in, and benefit, to and under, or relating to, among others, the Purchased Intellectual Property including but not limited to those set out in Schedule "A" hereto (collectively, the "Transferred IP").
- b) The Assignors and the Assignee desire to carry out the intent and purpose of the APA by their execution and delivery of this Agreement evidencing the sale, conveyance, transfer and assignment to the Assignee of all of the Assignors' rights, titles and interests in, and benefits to and under, or relating to, the Transferred IP.

NOW THEREFORE in consideration of the mutual covenants and agreements contained in this Agreement and other good and valuable consideration (the receipt and sufficiency of which are acknowledged), the Parties agree as follows:

- 1. **Defined Terms**. Capitalized terms used in this Agreement and its Schedule "A" hereto, but not otherwise defined have the meanings specified in the APA.

- 3. Third Party Beneficiaries. The Parties intend that this Agreement shall not benefit or create any right or cause of action in favor of any Person other than the Parties. - **Recordation**. The Assignors hereby authorize the Commissioner for Trademarks in the United States Patent and Trademark Office and the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions, to record and register this Agreement upon request by the Assignee.
