TERMINATION AND RELEASE
OF
FIRST LIEN NOTE INTELLECTUAL PROPERTY SECURITY AGREEMENT

February 7, 2024

THIS TERMINATION AND RELEASE OF FIRST LIEN NOTE INTELLECTUAL SECURITY AGREEMENT (this "Termination"), is dated as of the date hereof, and made by AccentCare Holdings, L.P., as the Holder under the Note (as defined below) (in such capacity, the "Holder"), in favor of (i) AccentCare, Inc., a Delaware corporation ("AccentCare"), (ii) Sta-Home Health & Hospice, Inc., a Mississippi corporation, (iii) Nurses Unlimited, Inc., a Texas corporation, (iv) Seasons Hospice & Palliative Care of Maryland, LLC, a Maryland limited liability company, (v) Seasons Healthcare Management, LLC, a – limited liability company and (vi) HRS Companies LLC, a – limited liability company (collectively, the "Grantors" and, individually, each, a "Grantor").

WHEREAS, the Grantors and Holder entered into (i) that certain First Lien Note Intellectual Property Security Agreement, dated as of July 18, 2023, by the Grantors in favor of the Holder and (ii) that certain First Lien Note Intellectual Property Security Agreement, dated as of December 12, 2023 (each of (i) and (ii), collectively, the "IPSAs"), by the AccentCare in favor of the Holder in which a security interest (the "Security Interest") was granted by the Grantors in favor of the Holder in certain IP Collateral;

WHEREAS, the IPSAs were originally recorded in (i) the Trademark Division of the United States Patent and Trademark Office ("USPTO") (x) on July 18, 2023, at Reel 8136, Frame 0001 and (y) on December 15, 2023, at Reel 8289, Frame 0551, (ii) the Patent Division of the USPTO on July 18, 2023, at Reel 064307, Frame 0706 and (iii) the United States Copyright Office ("USCO") on July 18, 2023, at Volume 15017, Document No. 039; and

WHEREAS, the Grantors have requested that the Holder execute and deliver this release to evidence the release of the Security Interest in the applicable IP Collateral for recordation with the USPTO and USCO, as applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Holder hereby states as follows:

Definitions. The term "IP Collateral", as used herein, shall have the respective meanings set forth in the applicable Security Agreement, or, if not defined therein, in the First Lien Note Pledge and Security Agreement, dated as of July 18, 2023 (including all exhibits thereto, as amended, restated, amended and restated, supplemented or otherwise modified) and shall mean and include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in and to such applicable IP Collateral, including in the trademarks listed on Schedule I attached hereto, the patents listed on Schedule II attached hereto and the copyrights listed on Schedule III attached hereto.


Release of Security Interest. The Holder hereby terminates the Security Agreements, and irrevocably terminates, releases and discharges the Security Interests in the IP Collateral and reassigns to the Grantors all right, title and interest that any Grantor may have in and to the IP Collateral without recourse and without any representation or warranty.

Recordation. The Holder authorizes the Grantors and their designees to record this Termination with the USPTO and USCO or any other applicable governmental authority at the Grantors' expense.
