The Corporation was first incorporated on August 7, 1991, in the State of Delaware by filing its original Certificate of Incorporation with the Secretary of State of the State of Delaware on such date, and immediately prior to filing this Certificate of Conversion to Limited Liability Company was a corporation incorporated in the State of Delaware.

2. The name and type of entity of the Corporation immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was Fiberspar Corporation, a Delaware corporation.

3. The name of the limited liability company into which the Corporation shall be converted as set forth in its certificate of formation is Fiberspar LLC, a Delaware limited liability company.

4. The conversion of the Corporation to the LLC shall be effective at 10:00 ET on December 27, 2021.
