**CERTIFICATE OF AMENDMENT
OF THE
RESTATED ORGANIZATION CERTIFICATE
OF APPLE BANK FOR SAVINGS
UNDER SECTION 8005 OF THE BANKING LAW**

FIRST, the name of the Corporation is APPLE BANK FOR SAVINGS. The name under which the Corporation was formed was HARLEM SAVINGS BANK.

SECOND, the Corporation was created under the name HARLEM SAVINGS BANK pursuant to an Organization Certificate filed by the Superintendent of Banks of the State of New York on April 17, 1863. The Corporation's Restated Organization Certificate was filed by the Superintendent of Banks of the State of New York on July 3, 1985. The Corporation's Restated Organization Certificate was most recently amended by Certificate of Amendment filed by the Superintendent of Banks of the State of New York on October 15, 1996.


THIRD, the text of Article I of the Restated Organization Certificate of the Corporation is hereby amended in its entirety to read as follows:

ARTICLE I


The name by which the Corporation is to be known is APPLE BANK.

FOURTH, the execution and filing of this Certificate of Amendment of the Restated Organization Certificate was, pursuant to Section 8003 of the Banking Law, authorized by the written consent in lieu of a meeting of the sole holder of 100% of the outstanding shares of capital stock of the Corporation, dated as of December 26, 2023.
