RELEASE OF SECURITY INTEREST
IN U.S. TRADEMARKS

This RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS, dated as of February 8, 2024 (this “Release”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a bank located at Eleven Madison Avenue, New York, NY 10010, as collateral agent (in such capacity, the “Collateral Agent”), in favor of ARCH RESOURCES, INC (f/k/a ARCH COAL, INC.), a Delaware corporation located at 1 CityPlace Drive, Suite 300 St. Louis, MO 63141, (“Grantor”). Each capitalized term used but not defined in this Release has the meaning given or ascribed to it in the Trademark Security Agreements (as defined below).

WITNESSETH

WHEREAS, the Grantor and Collateral Agent, amongst others, are parties to a Security Agreement, dated as of March 7, 2017 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, the Grantor entered into (i) a Trademark Security Agreement dated as of March 7, 2017, which was recorded with the United States Patent and Trademark Office on January 2, 2018 at Reel/Frame 6241/0020, and (ii) a Supplemental Trademark Security Agreement dated as of June 8, 2020, which was recorded with the United States Patent and Trademark Office on June 8, 2020 at Reel/Frame 6956/0095 (collectively, the “Trademark Security Agreements”), pursuant to which Grantor granted to and created in favor of the Collateral Agent, for the benefit of itself and the other Secured Parties, a continuing Lien on and security interest (the “Security Interest”) in and to all of the Grantor’s right, title and interest in, to, and under the Trademark Collateral, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto; and

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in all right, title or interest of Grantor in or to the Trademark Collateral, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto.

NOW, THEREFORE, the Collateral Agent hereby (i) unconditionally and irrevocably terminates and releases its Security Interest under the Trademark Security Agreements in all right, title or interest of Grantor in or to the Trademark Collateral, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto and (ii) reassigns, grants and conveys any and all such right, title and interest that the Collateral Agent may have in, to and under the Trademark Collateral to the Grantor.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release. The Collateral Agent agrees, at the Grantor’s sole cost and expense, to reasonably cooperate with the Grantor, including to provide the Grantor with the information and additional authorization reasonably required, to fully effectuate this Release.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
