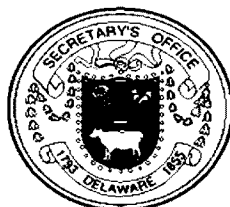


"FIRST: The name of the Corporation is RTX CORPORATION."
