IP SUPPLEMENT

This IP SUPPLEMENT, dated January 14, 2024 is delivered pursuant to and supplements (i) the Fourth Amended and Restated Security Agreement, dated as of June 26, 2018 (as it may be from time to time amended, restated, modified or supplemented, the "**Security Agreement**"), among The Wine Group, Inc., a California corporation ("**TWG Inc.**"), The Wine Group LLC, a Delaware limited liability company (the "**Company**", and together with TWG Inc., the "**Co-Issuers**"), The Wine Group LLC ("**Grantor**"), the other Grantors named therein, and Coöperatieve Rabobank U.A., a Netherlands cooperative with excluded liability, New York Branch ("**Rabobank**"), as Collateral Agent, and (ii) the Grant of Trademark Security Interest dated as of June 26, 2018 (the "**Grant**") executed by Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.

Grantor grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral listed on Schedule A attached hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grant.
