**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of February 5, 2024, by and between ANTARES CAPITAL CORPORATION, a Delaware corporation, as secured party (the “Secured Party”), and GOOD SOURCE SOLUTIONS, INC., a Delaware corporation (the “Debtor”). Reference is hereby made to that certain Trademark Security Agreement between the Debtor and the Secured Party dated as of January 6, 2006 (the “IP Security Agreement”), recorded at the United States Patent and Trademark Office at Reel 3223, Frame 0902 on January 10, 2006 (and as further corrected at Reel 3249, Frame 0789 on February 17, 2006). Terms used but not defined in this Release shall have the meanings given thereto in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Secured Party was granted a continuing security interest in and to all of the Debtor’s the Trademark Collateral, including the Trademarks listed on Schedule A;

WHEREAS, the Debtor has requested that the Secured Party terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office (the “USPTO”); and

WHEREAS, the Secured Party has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby terminates the IP Security Agreement and releases and terminates all security interests and other interests it may have in and to the Trademark Collateral. Debtor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.

The delivery of an executed counterpart of a signature page to this Release by email or facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the laws of the State of New York (without giving effect to its principles of conflicts of law) and shall relate solely to the IP Security Agreement.
