RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of February 12, 2024 (this “Release”), is made by BLUE OWL CAPITAL CORPORATION (formerly known as OWL ROCK CAPITAL CORPORATION), as collateral agent (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) for the other Secured Parties (as defined in the Credit Agreement (as defined below)) in favor of SHEARER’S FOODS, LLC, an Ohio limited liability company (the “Borrower”), SHEARER’S FOODS PERHAM, LLC (f/k/a BARREL O’FUN SNACK FOODS CO., LLC), a Delaware limited liability company, SHEARER’S FOODS BURLINGTON, LLC, a North Carolina limited liability company, and SHEARER’S FOODS SA, INC. (f/k/a SNACK ALLIANCE, INC.), an Oregon corporation (each a “Grantor” and, collectively, the “Grantors”). Capitalized terms used herein without definition are used as defined in the Security Agreement (as defined below).

W I T N E S S E T H

WHEREAS, the Borrower, the other Grantors and parties party thereto from time to time, and Collateral Agent, entered into that certain Second Lien Credit Agreement, dated as of September 23, 2020 (as the same may be amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Credit Agreement”) and that certain Security Agreement, dated as of September 23, 2020 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Second Lien Trademark Security Agreement, dated as of September 23, 2020 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on October 7, 2020 at Reel/Frame Nos. 7072/0579, 7087/0361, and 7093/0792 pursuant to which the Grantors mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest, liens and all other right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest of the Collateral Agent in the Trademark Collateral is hereby discharged, terminated and released and shall hereby cease and become void. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
