RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of February 8, 2024 (this “Release”), is made by Sixth Street Specialty Lending, Inc. (f/k/a TPG Specialty Lending, Inc.), in its capacity as agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, the “Agent”) in favor of Billhighway LLC (the “Grantor”). All terms used but not otherwise defined herein have the meanings given to them in the Guaranty and Collateral Agreement.

WITNESSETH

WHEREAS, the Grantor, among others, and the Agent are parties to that certain Guaranty and Collateral Agreement, dated as of October 10, 2019 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “Guaranty and Collateral Agreement”);

WHEREAS, pursuant to the Guaranty and Collateral Agreement, the Grantor executed the Trademark Security Agreements, dated as of October 10, 2019 and October 16, 2019 (the “Trademark Security Agreements”) and recorded with the U.S. Patent and Trademark Office on October 14, 2019 at Reel/Frame Nos. 6771/0154 (with regards to the October 10, 2019 Agreement); and recorded on October 16, 2019 at Reel/Frame Nos. 6773/0219 (with regards to the October 16, 2019 Agreement), pursuant to which the Grantor granted and pledged to the Agent a continuing security interest in all of the Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including without limitation the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Collateral Agreement and the Trademark Security Agreement.
