RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of February 6, 2024 (“Effective Date”) by **BANKUNITED, N.A.**, as Administrative Agent (the “Administrative Agent”), in favor of **RYZE CLAIM SOLUTIONS LLC**, an Indiana limited liability company (“Obligor”).

WHEREAS, pursuant to the terms and conditions of that certain Notice of Grant of Security Interest in Trademarks by and between Obligor and Administrative Agent dated as of September 29, 2023 (the “Trademark Security Agreement”), Obligor granted to Administrative Agent a continuing security interest in and continuing lien upon the trademarks and trademark applications set forth on Schedule 1 hereto, together with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on September 29, 2023, at Reel 8213, Frame 0475; and

WHEREAS, Obligor has paid all of its outstanding indebtedness to Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks and; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule 1, in any jurisdiction throughout the world.

Administrative Agent shall take all further actions, and provide to Obligor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Obligor to more fully and effectively effectuate the purposes of this Release.
