RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 6, 2024, is made by UMB BANK, NATIONAL ASSOCIATION, (the “**2025 Notes Collateral Agent**”) in favor of AKUMIN INC., AKUMIN IMAGING TEXAS, LLC, AKUMIN FLORIDA HOLDINGS, LLC, ALLIANCE ONCOLOGY, LLC, ALLIANCE HEALTHCARE SERVICES, INC., THREE RIVERS HOLDINGS, LLC, AND USR HOLDINGS, LLC (each, a “**Grantor**” and, collectively, the “**Grantors**”).

WHEREAS, pursuant to the U.S. Pledge and Security Agreement, dated as of November 2, 2020 (the “**2025 Pledge and Security Agreement**”), by and among the Grantors (as defined therein) party thereto and the 2025 Notes Collateral Agent, the Grantors pledged, collaterally assigned and granted to the 2025 Notes Collateral Agent a security interest in all of the Grantors’ right, title and interest in the “Collateral” (as defined therein), including the trademarks set forth on Schedules 1, 2 and 3 attached hereto (the “**Trademarks**”);

WHEREAS, pursuant to that certain (x) Notice of Grant of Security Interest in Trademarks, dated as of November 2, 2020 at Reel 7123, Frame 0353 in the United States Patent and Trademark Office (the “**2020 Trademark Security Agreement**”) and (y) Notice of Grant of Security Interest in Trademarks, dated as of November 2, 2020, by certain of the Grantors in favor of the 2025 Notes Collateral Agent, which was duly recorded on November 2, 2020, by certain of the Grantors in favor of the 2025 Notes Collateral Agent, which was duly recorded on January 11, 2021 at Reel 7160, Frame 0057 in the United States Patent and Trademark Office and (z) Notice of Grant of Security Interest in Trademarks, dated as of September 1, 2021 at Reel 7411 Frame 0324 in the United States Patent and Trademark Office (“the 2021 U.S. Pledge and Security Agreement”) (the “**2021 Trademark Security Agreement**”, the “2021 U.S. Pledge and Security Agreement” and collectively with the 2020 Trademark Security Agreement, the “**Trademark Security Agreements**”), the Grantors granted to the 2025 Notes Collateral Agent, to secure its obligations under the Pledge and Security Agreement, a security interest in all right, title and interest of the Grantors in and to certain intellectual property, including the Trademarks set forth on Schedules 1, 2 and 3 attached hereto;

WHEREAS, the 2025 Notes Collateral Agent wishes to release and restore all right, title and interest in the Trademarks to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreements.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the 2025 Notes Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under each Trademark Security Agreement in the Applicable Collateral (as defined in the applicable Trademark Security Agreement), including the Trademarks, (b) release its security interest in the Applicable Collateral, including the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to 2025 Notes Collateral Agent in the Applicable Collateral and all goodwill associated therewith, including the Trademarks.

2025 Notes Collateral Agent shall take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantors, and at the Grantors’ cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby. 2025 Notes Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office and the Canadian Intellectual Property Office note and record the present Release of Security Interest in Trademarks.





